# INFORMATION ABOUT THE UPDATE

**WHO SHOULD ATTEND:** Nursery and greenhouse personnel, landscape contractors and maintenance personnel, landscape architects, landscape designers, arborists, pest control operators & garden center managers.

## **PESTICIDE CREDITS/ARBORIST CREDITS/FNGLA CREDITS/CEU's:**

### **Florida:**

- FNGLA will grant 4 CEUs for FCHP, FCLC, FCLT or FCLD certifications.
- The Pesticide Certification Office has approved a maximum of 3 CEUs for Florida pesticide applicators with up to 2 CEUs in CORE and 1 CEU each in Ornamental and Turf Pest Control, Private Applicator Ag Pest Control, Commercial Lawn and Ornamental, Limited Certification Commercial Landscape Maintenance or Limited Certification Lawn and Ornamental.
- The International Society of Arboriculture, Florida Chapter, will grant 6 CEUs.

### **Georgia:**

- Three pesticide re-certification credits in Category 24: Ornamentals and Turf, and Category 21: Agricultural Plant for holders of commercial licenses and 2 hours for private pesticide licenses.
- ISA-Southern Chapter will grant 6 CEUs distributed in the categories of Arborist, BCMA Science, BCMA Practice, Municipal, and TW Climber Specialist.

### **South Carolina:**

- Participants from South Carolina will earn 3 hours of pesticide re-certification credits.
- ISA-Southern Chapter will grant 6 CEUs distributed in the categories of Arborist, BCMA Science, BCMA Practice, Municipal, and TW Climber Specialist.
